1. LSM Report (Bruce Ritchie)

Scoping Report / Statutory Intervention Action Plan - Issues Analysis discussed and agreed.

Monthly template reporting showing how we are tracking, with both Pasifika and Maori.

Reporting on progress - teacher appraisals, next month Jason Borland will present on digital enablement in school and how that is impacting on student learning.

One of the biggest issues, not apparent at the outset of the intervention was the low levels of literacy and numeracy of students entering at Year 9. John to provide entry data from feeders schools to support this

Bruce will report monthly to BOT on the Statutory Intervention Action Plan once it is finalised.

2. Principal's Reports September and October (JR)

Discussed Whanau plan for 2017, making very good progress with school restructuring plan with engagement from all different groups, next step is to share the look of this with our school community and families. We are well underway in the process of making appointments for our leadership roles, Kaiarahi Whanau and Kaitiaki Akonga. Ngati Tamaoho are naming our three whanau and preparing cultural

narrative for each. Once these have been finalised John will put out to our families and community.

The most consuming current issue is our Provisional Staffing for 2017 and MOE's original predictions as to what our 2017 roll will look like. Prediction from MOE was 7 teachers. John has challenged MOE and as a result John Clark from MOE Resourcing Wellington and Ted Benton came and met with him and subsequently a review request has been submitted for five extra staff to be fitted within that loss. Without these staff we will not be able to meet the needs of our priority learners by offering classes that meet their needs which is critical in both engaging our students and student retention. We are currently losing our Maori students because we are not meeting their needs. At the beginning of this year John applied for Services Academy, unfortunately this was turned down however he continues to look at other areas that may promote student retention in the senior school.

In summary John is optimistic that the Ministry is going to be accommodating on this staffing request and acknowledged Ted Benton's efforts to support us.

John moved his Principal's Reports for September and October be accepted.
