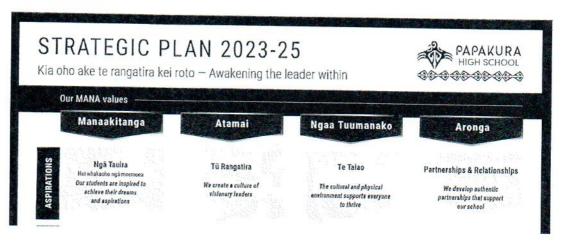

480 students were surveyed in August 2023

There are four key domains. Students with positive results in these areas are more likely to stay in school and be successful.

Kia oho ake te rangatira kei roto - Awakening the leader within

Less students in Year 11 were surveyed than in previous years.

Other agencies are very interested in the results of this survey, especially in regards to the Health & Wellbeing outcomes.

The survey is international from Iceland, surveys are carried out around the world but in New Zealand, only in Papakura.

More boys than girls claim to have better mental health and better communication to adults. Many of the responses/results are common across a large percentage of the students surveyed and not unique to Papakura High School.

How do the results of the survey relate to what the school is trying to achieve and the school's strategic plan?

The importance of having good relationships is highlighted in the results of the use of drugs and alcohol. Why do students/young people feel the need for these? To fill a need?

The data is of benefit to the local community but will only be released with the permission of the participating schools and once the results are amalgamated and guaranteed totally anonymous.

Most survey regions do not include questions of ethnicity as in many cases it is not relevant information. However, for Papakura, this is a very valid consideration and gives valuable insights.

Students performed exceptionally well at Polyfest. Skylah Turei was a deserved recipient of the Mana Wahine Award for the kapa haka competition.

A trained teacher who has been relieving at the school has been approached to mentor our Year 13 students who are showing signs of disengaging from school - lowering attendance rates etc

Big thanks to all board members who attended the blessing of the Whānau Pou on Monday morning.

Provisional results of the ERO visit to the Rumaki Oranga Reo show positive results of the SLT leadership of the area and work to do in some other areas.

The ERO team was impressed with the students and their desire to learn.

There are a number of new members of the community coming into school to run/help with Pro-Jects and Electives.

Kootuitui has donated \$50,000 for STEAM (Science, Technology, Engineering, Mathematics and Arts) projects.

Roll growth: at the 1st March roll return there were 150 more students than 2023.

Provisional staffing entitlement was 54.3. This is now confirmed as 61.6. We started the year over staffed but are now looking to appoint approx. 5 more staff members, three in the junior classes and two heads of department. This also means an increase of 5MUs and 9MMAs. Classrooms will not be able to be used by only one teacher, they will need to be shared spaces.

The increase in student numbers also means that the school receives more MOE funding.
